Ongoing meetings

Cost	
Minimum Annual Charge	The cost of this service is 0.75% of your funds under review. The minimum charge for this service is £750 per annum. This can be paid either by cheque or through your product. This can also be paid monthly by Standing Order.
	<i>Example of cost</i> = £75,000 funds under review (FUR) £75,000 x 0.75% = £562.50. Therefore an additional payment of £187.50 would be payable to meet our minimum £760 per annum charge. This extra charge can be taken directly from the product if requested.
	<i>Example of cost</i> = £120,000 funds under review (FUR) £120,000 x 0.75% = £900.00. Therefore no additional payment would be payable to meet our minimum £750 per annum charge.
